Official Rules of the Inspiring Youth Prom Program 2015

OPEN ONLY TO LEGAL RESIDENTS OF HARRIS OR MONTGOMERY COUNTY IN THE STATE OF TEXAS WHO ARE ENROLLED FULL-TIME IN CYFAIR HIGH SCHOOL WHO HAVE AN IMMEDIATE OR SPECIAL NEED AND WHO ARE ELIGIBLE TO ATTEND THE SCHOOL PROM AS OF THE DATE OF ENTRY AND WHOSE PROM WILL NOT TAKEN PLACE BY THE END OF MAY 2016.

By entering the Inspiring YOUth Prom program, entrants accept and agree to be bound by these Official Rules. Any violation of these rules may, at Sponsor's discretion, result in disqualification. Recipients shall be elected via random drawing. All decisions of the judges regarding this Promotion are final and binding in all respects.

1. ENRTY PERIOD. The entry period begins 12:01 AM ET 11/01/15 and ends 11:59 PM ET 3/15/16 ("Entry Period"). Online and hand-delivered entries must be received by the end of the Promotion Period. Mail-in entries must be postmarked by the end of the Promotion Period, and received no later than five (5) days later.

2. ELIGIBILITY. This Program is void outside of Harris County in the state of Texas, and where prohibited.

3. HOW TO ENTER. Entries must be mailed in for entry and must include an original essay of no more than 300 words describing your achievements as a student at your high school as well as why you deserve to win. Included in your essay should be any extenuating circumstances of immediate or special needs. If entrant is unable to complete the essay themselves a parent, guardian or counselor may do so on your behalf but must disclose the reason for doing so. Additionally, examples of your academic achievements, awards, extracurricular activities and community service, along with an official entry form which includes your name, home address, phone number, the name of your date, school, and the location and date of your prom ("Entry Form"). Entrant further represents and warrants that their Submission adheres to the fundamental spirit of the Promotion and does not contain any defamatory, obscene or otherwise unlawful matter or depict anyone engaged in any illegal, immoral or lewd act, any violent or pornographic material or contain any other inappropriate content (as determined by Sponsor). Limit: One entry per person and one entry per e-mail address during the Promotion Period. 4. WINNER SELECTION AND NOTIFICATION. All entries will be judged on or about March 15, 2016 (the "Judging Date") by a panel of judges comprised of the Board of Directors of Inspiring HANDS, Inc. The judges will score entries based on the following criteria: immediate need (25%), special needs (25%), entrant's school achievements (25%), and clarity of writing of the essay (25%). In the event of a tie, the entry with the higher score in the creativity and originality criteria will prevail. The top fifty (50) entries with the highest overall score will be entered into the random drawing of ten (10) declared potential winners followed by ten (10) alternate winners. Any potential winner will be notified by mail, email and/or telephone no later than April 1, 2016. If a potential winner: (i) cannot be contacted; (ii) does not respond within three (3) days from the date the Sponsor first tries to notify him/her; (iii) fails to return the Affidavit and Release as specified in Rule 9; (iv) refuses the prize; and/or (v) the prize or prize notification is returned as undeliverable, such potential winner forfeits all rights to win the Program or receive the prize, and an alternate potential winner may be selected.
