Official Rules of the Inspiring Youth Prom Program 2015

OPEN ONLY TO LEGAL RESIDENTS OF HARRIS OR MONTGOMERY COUNTY IN THE STATE OF TEXAS WHO ARE ENROLLED FULL-TIME IN TOMBALL SENIOR OR TOMBALL MEMORIAL HIGH SCHOOL AND WHO ARE ELIGIBLE TO ATTEND THE SCHOOL PROM AS OF THE DATE OF ENTRY AND WHOSE PROM WILL TAKE PLACE IN APRIL OR MAY OF 2015.

By entering the Inspiring YOUth Prom program, entrants accept and agree to be bound by these Official Rules. Any violation of these rules may, at Sponsor's discretion, result in disqualification. Recipients shall be elected via random drawing. All decisions of the judges regarding this Promotion are final and binding in all respects.

- 1. **ENRTY PERIOD**. The entry period begins 12:01 AM ET 1/15/15 and ends 11:59 PM ET 4/01/15 ("Entry Period"). Entries must be received by the end of the Promotion Period. Mail-in entries must be postmarked by the end of the Promotion Period, and received no later than three (3) days later.
- 2. **ELIGIBILITY**. The program is only open to legal residents of Harris and Montgomery County, Texas who are enrolled full-time as a senior at Tomball Senior or Tomball Memorial High School and are eligible to attend the school Prom as of the date of entry, and whose prom will take place in April or May of 2015, except officers, directors, members, and employees of the Sponsor, the judging organization (if applicable), or any other party associated with the development or administration of this Program, and the immediate family (i.e., parents, children, siblings, spouse), and persons residing in the same household, as such individuals. This Program is void outside of Harris or Montgomery Counties in the state of Texas, and where prohibited.
- 3. **HOW TO ENTER**. Entries must be mailed in for entry and must include an original, completed and signed entry form. Incomplete forms will not be considered. Entrants represent and warrant that their Submission is truthful and it does not violate the rights of any other person or entity. Entrant further represents and warrants that their Submission adheres to the fundamental spirit of the Promotion and does not contain any defamatory, obscene or otherwise unlawful matter or depict anyone engaged in any illegal, immoral or lewd act, or contain any other inappropriate content (as determined by Sponsor). Limit: One entry per person during the Promotion Period. All entrant information, including e-mail addresses, is subject to the respective Privacy Policy.
- 4. **WINNER SELECTION AND NOTIFICATION**. Winners identity will be kept confidential other than as required to grant certificates by sponsors. All entries will be judged on or about April 5, 2015 (the "Judging Date") by a panel of judges comprised of the Board of Directors of Inspiring HANDS, Inc. The judges will score entries based on the following criteria: Timely submission (50%) and extenuating circumstance (50%).
